The school is in the process of constituting the school PTA and subsequently the SCHOOL LEVEL FEE COMMITTEE (SLFC) of the parents whose ward(s) is/are studying in the school for the academic session 2025-2026.

PROVISIONS OF RAJASTHAN SCHOOL (REGULATION OF FEE) ACT, 2016 AND OF RAJASTHAN SCHOOL (REGULATION OF FEE) RULES, 2017

SECTION 4. Parent-Teacher Association: -

- Every private school shall constitute Parent-teachers Association. (a)
- (b) The Parent-teachers Association shall be formed by the head of the school. Every teacher of the school and parent of every student in the school shall be a member of Parent-Teachers Association and an annual amount of rupees fifty, in case of urban area shall be collected from each member of such association. This will be functional from April 2024.

Eligibility/Conditions:

- 1. Parents (PTA members) who the through E-mail give consent (virasatvidyapeeth@gmail.com) or written application submitted to the school office by hand dated on or before 30 April 2025 will be considered. The written application should reach the school office by 12:00 noon on 30 April 2025. The last date for mail is also the same. (if the applicant submits hand written application for SLFC then all the relevant details asked should be with the letter). If the application is submitted through email, hardcopy should be submitted to the school office.
- 2. As per the Act, the application fee of Rs.50 is to be paid in the office.
- 3. The ward should be studying in the school in the academic session 2025 2026 in classes 1 to 12.
- 4. If more than one child is studying, only one consent form per family will be considered.
- 5. The applicant should have sufficient knowledge about the functioning of the school system, financial matters and the relevant guidelines of the government on SLFC related issues.
- 6. Should not be a habitual defaulter in paying fees (as on 20-04-2025 in our school records, and before should have been completed with 1st installments of 2025 - 2026 must have been cleared)
- 7. Has been always cooperative with the school.
- 8. If applying in person submitted a printed application on A4 size sheet with all the supportive self-attested copies of the documents: Adhar Card, Last year report card, certificate of highest qualification, and cash payment receipt.
- 9. The applicant should attach his/her highest qualification marksheet or certificate.
- 10. Once the application is submitted, it cannot be changed, so kindly fill the correct details. In the event of any incorrect information, the application will be summarily rejected.
- 11. In case there are excessive number of entries, the final selection would be done by lottery.
